### **RULEBOOK OF THE MONTENEGRO WATER POLO CAMP TIVAT, 2018**

\*Campers shall come to training sessions, swimming pool, go to excursions and other facilities of the Camp in the company of their coaches.

\*Camper shall show respect for the work of the coaches and adhere to the instructions of the same, both during the training sessions and outside the same, with the purpose of carrying out the programme of the Camp and maintaining the level of discipline at the Camp.

\*Campers shall act responsibly and adhere to the timetable of the Camp.

\*Campers shall come to the restaurant at the scheduled time.

\*Campers shall be in their rooms at 11 p.m. and shall not leave the same after 11 p.m.

\*Campers shall bring appropriate sports equipment to the training sessions.

\*Campers shall have their photographs taken in their sports equipment at the time scheduled for photo shoot. Montenegro Water Polo Camp retains the right to publish the photographs in the media and on the Internet, with the purpose of advertising the Camp.

\*Campers shall give media statements should a need arise for that. The Camp organizer retains the right to publish the interviews and photographs.

\*Should a camper have medical issues he/she shall promptly approach the coach and the on-duty doctor who is available 24 hours a day, so as to receive timely medical assistance.

\*Campers shall take care of their belongings (money, cell phone, jewelry ...). The camp organizer shall not be obliged to take care of the campers' personal belongings.

\*Should a camper have a need to leave the Camp, in order to see to his/her personal affairs /got to the store, Post Office, bank... he/she shall ask for permission from the on-duty coach. Upon receiving the permission, the camper may leave the Camp solely to see to the need/affair he/she has got the permission for. The camper shall return to the Camp at the agreed time and shall notify the coach of his/her return. The Coach and the Water Polo Camp shall not be held liable for the camper until his/her return to the Camp, thus the camper shall behave properly and shall be liable for consequences of improper conduct.

\*Should a camper leave the Camp of his/her own accord, without asking for permission from the coach, he/she shall be held responsible for the consequences. In such case, the organizer of the Water Polo Camp is entitled to exclude the camper from the Camp without a duty to return the money.

\*All campers shall be insured during the Water Polo Camp by \_\_\_\_\_, which is entitled to contact the interested parents within a foreseeable time, via e-mail or telephone so as to offer its services.

\*In case a camper brings spirits to the hotel or consumes the same during the Camp, the organizer is entitled to exclude him/her from the Camp immediately and shall have no duty to return the money to the same.

\*In case a camper uses cigarettes and stupefying drugs during the Camp, the organizer of the Water Polo Camp shall have the right to exclude him/her from the Camp without a duty to return the money to the same.

\*In case a camper endangers himself/herself or the others by acting irresponsibly (sits in the hotel room window sill, leaves the room at the time of night rest, takes part in an argument or fight etc.) he/she shall bear his/her own consequences, and the organizer of the Water Polo Camp is entitled to exclude him/her from the Camp immediately without a duty to return the money to the same.

\*In case a camper wishes to leave the Camp for private reasons or for attending to his/her personal duties, he/she shall notify the Camp Management accordingly and provide conditions for leaving the Camp, otherwise the water Polo Camp shall not be obliged to return the money to the same.

\*Campers shall treat the Camp Management, personnel, coaches and other campers with respect, conscientiously and responsibly. Campers shall take care of the property belonging to the Camp, Hotel, swimming pool and other facilities and they shall use the same and their fixtures in a proper manner. In case a camper causes damage, he/she shall be obliged to recover the damage. The parents of a juvenile shall be held responsible for the damage caused by their child.

\*Every conduct contrary to the provisions of this Rulebook will be sanctioned by the exclusion of a camper from the Camp, without a duty to return the money. The camper shall be obliged to provide conditions for his/her immediate departure from the Camp. The parents of a juvenile camper will be promptly notified of the breaches of the Rulebook by their child. The parents shall

be obliged to pick up the camper without delay and no later than within 12 hours as of the notification and to assume the care over the same.

\*The Water Polo Camp shall not bear any liability for the conduct of the camper which is contrary to the provisions of the Rulebook or for material and immaterial damage caused.

\*Every abusive behaviour on the grounds of race, politics, sex etc. is strictly forbidden and it will be considered a sufficient enough a reason for the exclusion from the Camp without a duty to return the money.

\*The Rulebook on the Conduct of Campers is the integral part of the Agreement with Parents (Guardians) on the Conditions for the Organization of the Water Polo Camp and Payment of Fees. By making payment for the participation at the Camp, both campers and the parents to juvenile campers accept the adherence to the provisions of this rulebook. The Rulebook is available on the website of the Water Polo Camp ([www.waterpolo.camp](http://www.waterpolo.camp)). Campers and their parents are obliged to become acquainted with the provisions of the Rulebook before making payment for the participation at the Camp. The parents of juvenile campers are obliged to warn the children of the adherence to the Rulebook. In case the campers act contrary to the provisions of the Rulebook, their parents shall be held liable for the potential damage caused.
